Members Present Reviewed The Previous Minutes and Remarked That They Were O.k.

While A Few Board Members were Delayed, The Meeting Started On Time. The Items Of The Agenda Were Discussed Out Of Order Because Those Present Reviewed A Map Of

Manchester And Surrounding Areas Which Indicated over 1 Billion Dollars Of Planned Or Existing Developments. The Developments Included Continental Development,

\$26 Million, Ultra At PNC Park \$75 Million, Acrisure Stadium \$150-300 Million, Ft. Duquesne, West End And McKees Rocks Bridge Improvements \$132 Million, Kamin Science Center \$65 Million, And Esplanade \$500 Million.

One Of The Members Questioned If We Were Too Late In Sharing The Information Because It Appears The Development Activities Are Already Written In Stone. Another Member Commented That She Doesn't Believe Most Neighborhood African American Residents Are Aware Of The Magnitude Of The Proposed Changes. After A Brief Conversation, Concerning Possible Next Steps, It Was Noted That The Entire African American Community Must Meet To Learn About These Activities. The Group Also Decided That No Matter The Process Or Outcome As An Organization We Must Stick Together, Trust Each Other, And Provide The Information. It's Having A Great Impact On Our Community And Our People. The Consensus Was That We Convene a Community Meeting June 6, 2024, At The Comfort Inn East Ohio Street. We Will Invite Dr. Daniel Holland To Speak And Review The Data. The Meeting Will Be Called Manchester Community Meeting and Dinner. Dinner Will Commence At 6 p.m. The Presentation Will Commence at 7 p.m. The Results Will Determine If We Will Sponsor A Manchester Community Housing And Economic Development Billion Dollar Bus Tour. It Will Detail Every Possible Housing and Commercial Development Site Effecting The Community. The Members Established A Program and Dinner Committee. Roberta Bowra agreed to Seek Staging For the Bus Tour.
